

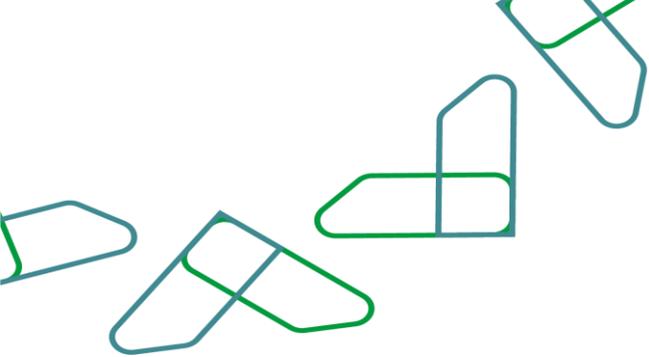

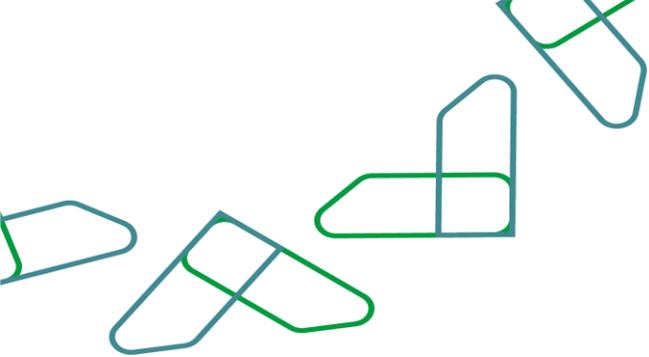

Etimad's developer platform [<https://www.apiportal.etimad.sa>] provides many API products, tools, and resources that enable you to complete many functions in your entity.

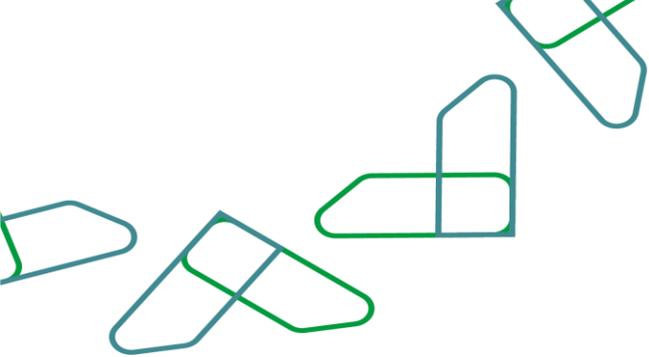
This document describes what's possible to build with the different tools and APIs that are available on the platform, and how to get the access and information that you need to get started.

Connectivity will be through GSN.



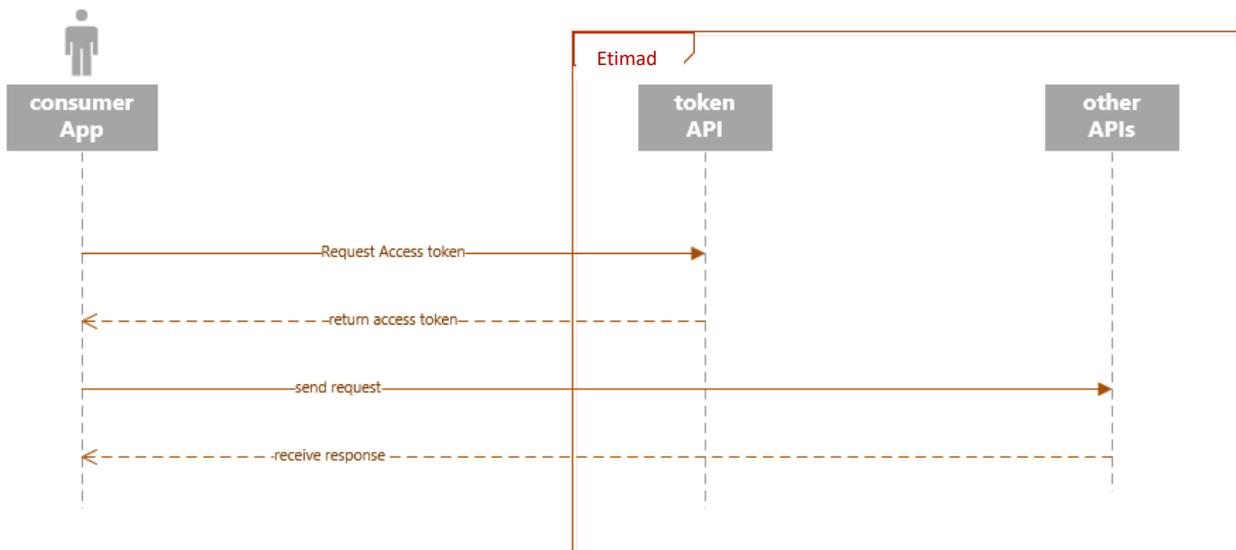

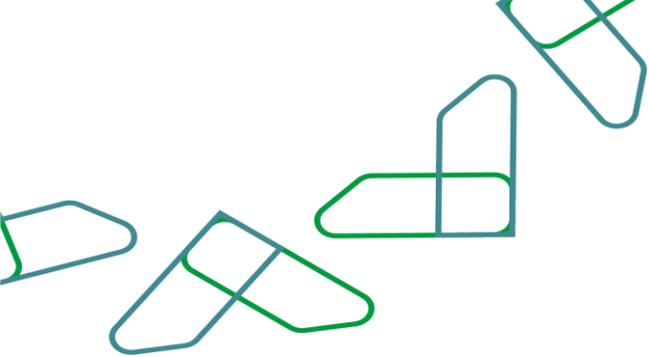

State Diagram & Sequence Diagram

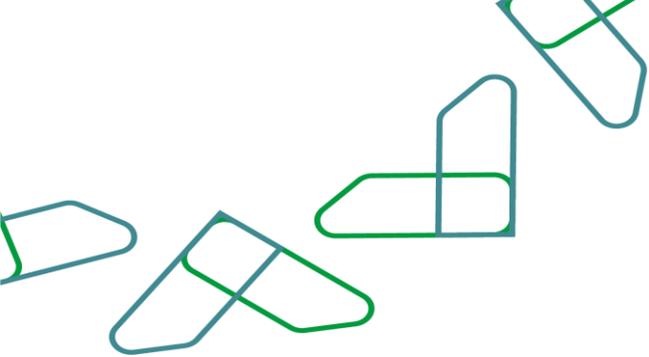

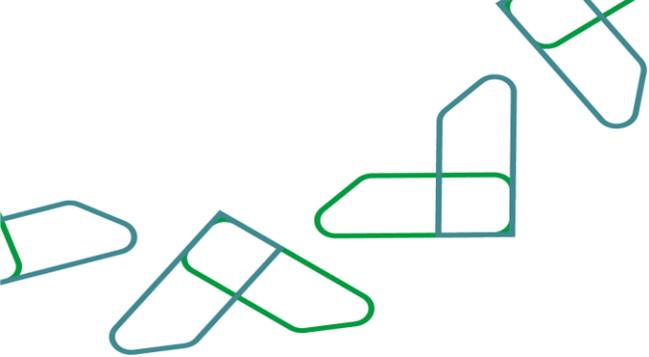
